
The following candidates have been selected for admission to **M.Phil. Business Administration** for the academic year 2021-23, subject to the following conditions:-


1. Any candidate who is found at any time to have obtained admission by making any miss-statement in the Admission Form or by willful concealment of any material fact (particularly about marks, division, previous admission to this or other Department/Center/Institute/College/Campus or employment, expulsion, conviction etc.) shall be dropped from the rolls of Gujranwala Campus.
2. Original Academic Documents and two pictures are required to be submitted to the University Authorities before obtaining Challan Forms for deposit of dues and will be retained by the University for Verification, and Please bring the original admission fee payment challan along with your documents.
3. The students shall have to submit Equivalence Certificate and NOC (if required), Medical Fitness Certificate & an Original Affidavit (specimen available from the campus office (Room # 19) before obtaining Challan Forms.
4. The students shall pay their dues amounting to Rs. 22,575 plus registration (Rs. 4500) for Non PU Graduates only, in Habib Bank Limited, Gujranwala Campus Booth after obtaining necessary Challan Forms from the office (Room # 19), before the close of banking hours by the last date i.e. **Monday, 8th November 2021**.
5. Students are required to submit the photostat copy of Challan in the same office after payment of dues.
6. Those who do not deposit their dues within this period shall lose their right to admission.
7. The University reserves the right to correct any typographical error, omission, etc.
8. Next Merit list (if required) will be displayed on **Wednesday, 10th November 2021**.


