1. Any candidate who is found at any time to have obtained admission by making any miss- statement in the Admission Form or by willful concealment of any material fact (particularly about marks, division, previous admission to this or other Department/Center/Institute/College/Campus or employment, expulsion, conviction etc.) shall be dropped from the rolls of Gujranwala Campus.
2. Original Academic Documents and two pictures are required to be submitted to the University Authorities before obtaining Challan Forms for deposit of dues and will be retained by the University for Verification.
3. The students shall have to submit Equivalence Certificate and NOC (if required), Medical Fitness Certificate & an Original Affidavit (specimen available from the campus office) before obtaining Challan Forms.
4. The students shall pay their dues amounting to **Rs. 26,497** , in Habib Bank Limited, Gujranwala Campus Booth after obtaining necessary Challan Forms from the office, before the close of banking hours by the last date i.e. **Wednesday, 11th September 2019**.
5. Students are required to submit the photostat copy of Challan in the same office after payment of dues.
6. Those who do not deposit their dues within this period shall lose their right to admission.
7. The University reserves the right to correct any typographical error, omission, etc.
8. Next Merit list (if required) will be displayed on **Thursday, 12th =September 2019**.
